I acknowledge that: - (a) this Agreement is governed by the laws of the State of Victoria, the Courts of which shall have exclusive jurisdiction, (b) this written Agreement constitutes the entire agreement between myself and the organisers and is intended to be interpreted as broadly as possible in favour of the Organisers, (c) if any part of this agreement is determined to be unenforceable all the other parts shall be given full force and effect.
